## What We Do

MENTOR is a court-based program coordinated by Judge Michael Erdos and Judge Lisa Rau that matches individuals serving non-violent county sentences with volunteer mentors to create healthier communities and families, and decrease the various human and financial costs associated with crime, prosecution, and incarceration.

Over the course of the one-year program term, mentors provide:

- Practical assistance to overcome the traditional barriers to successful reentry
- Emotional support
- Encouragement
- Referrals to additional resources through our network of community-based partner organizations

Mentors and participants meet twice monthly, communicate twice weekly, and attend monthly court status hearings to assess progress and address challenges. Educational programming is provided at each status hearing on topics such as job readiness, life skills, and emotional health.

When a participant successfully completes the MENTOR Program, they receive a substantial reduction in the remaining term of court supervision.
