- SHARP – home repairs include replacing exterior doors and locks, rebuilding basement steps, making minor plumbing repairs and replacing electrical switches, outlets and fixtures. Priority service is given to low-income people with physical disabilities who are over 75 years old and living alone.
- ADAPTIVE MODIFICATION PROGRAM (AMP) provides major modifications to the homes of senior citizens with physical disabilities.
- EMERGENCY FUND - offers small grants to needy elderly over age 60 to meet emergency energy, food, housing and medical needs.
- PROPERTY TAX REBATES- for senior citizens 65 years or older. Must have owned and occupied your house or apartment, nursing home or similar residence in Pennsylvania; been a widow or widower during all or part of the previous year; or permanently disabled during all or part of the previous year. Income guidelines apply. Proof of ownership is required.

- **HEATER HOTLINE** – emergency repair services for low income homeowners. **215.568.7190**
- **LOW INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP)** - helps homeowners or renters who are unable to pay their utility bills.
- **ENERGY EFFICIENCY AND CONSERVATION SERVICES** – provide energy conservation services to eligible households under contracts with local utilities and government. These include gas, water and electricity.
- **EMERGENCY FUEL ASSISTANCE PROGRAM (CRISIS)** - helps provide homeowners or tenants with heating including oil deliveries. Client must be without oil or heating service has been cut off (seasonal availability).
- **HOMELESSNESS PREVENTION PROGRAM** - case management for utilities assistance. Applicant must be facing a utility shut-off or in need of heating oil. Income guidelines and eligibility requirements apply.

- **Homeowners Energy Efficiency Loan Program (HEELP):** This is a 1% loan for homeowners that can provide up to \$10,000 for roof replacements, heating/cooling system repairs or replacements, caulking/sealing/insulating and new windows and doors. Repayment for the maximum loan of \$10,000 is \$88/month.
- **Renovate & Repair Loan Program:** A R&R loan can be used to pay for repairs and improvements that increase the basic livability of the home, including additions and construction, that makes the home safer, more energy efficient, or more accessible to people with disabilities or people who are elderly. R&R loans can also be used to remove or fix code violations, hook up to municipal water and sewer systems, and improve or install code-compliant septic or well systems. In addition, R&R loans can be a source of payment for emergency repairs to critical life-safety systems in the homes, as long as the loan application is made to the Local Program Administrator within 30 days of the repair.

- **Mini-PHIL:** Helps Philadelphia homeowners with less-than-perfect credit obtain the money needed to make energy conservation improvements, emergency repairs or to do small projects (Up to \$10,000). You can use leftover funds to pay off existing consumer debt.
- **PHIL-Plus:** Helps Philadelphia homeowners with less-than perfect credit obtain the money needed to do large repairs or to make big improvements (Up to \$25,000). You can use leftover funds to pay off existing consumer debt.

# SENIOR CITIZEN TAX ASSISTANCE

Provides following services:

- **Owner Occupied Payment Agreement:** If you have fallen behind in your real estate taxes, you may apply for an agreement that will allow you to pay your delinquent taxes in monthly installments over an extended term. Your monthly payment will be determined based on your income.
- **Homestead Exemption:** Reduces the taxable portion of your property assessment by \$30,000. If you are approved for the Homestead Exemption, your real estate tax bill will likely be lower next year. The application deadline for the 2015 tax year is September 13, 2014.
- **Current Real Estate Tax Installment Plan:** If you cannot pay all of your current real estate taxes by the March 31 due date each year, you may apply to pay your taxes in monthly installments. If you are approved, you will receive a coupon book to make payments.
- **Senior Citizen Tax Freeze:** If you are an income-eligible senior citizen, the City of Philadelphia will "freeze" your real estate tax. Once approved, if your assessment changes or the tax rate changes, your taxes due will not increase
- **PA Property Tax Rebate:** If you are approved for this program, you will receive a rebate of some or all of your real estate taxes.
- **Active Duty, Reserve, and National Guard Tax Credit:** If you are a member of the National Guard or a reserve component of the Armed Forces of the United States who is called to active duty outside of Pennsylvania, the City of Philadelphia may give you a tax credit against real estate taxes
- **Disabled Veterans Real Estate Tax Exemption Program:** A military veteran who is 100% disabled, has service-related disability, and demonstrates a financial need may qualify for a 100% exemption from real estate taxes. Upon the death of a qualified veteran, this exemption may pass on to a surviving spouse.
- **Longtime Owner Occupants Program (LOOP):** If you have lived in your home at for least 10 years and your property has a substantial increase in assessed value, the City may give you significant tax savings for 10 years. The application deadline was February 18, 2014; applicants will find out if they have been approved by March 31, 2014.
