## **NOTICE OF FEE INCREASE**

## RE: ACTS 40 AND 44 OF 2017 - CHANGES IN EXISTING JCS/ATJ/CJEA/OAG FEE

Effective **October 30, 2017**, Acts 40 and 44 of 2017 increased the JCS/ATJ/CJEA/OAG fee by \$4.75 bringing the total fee from \$35.50 to **\$40.25**. The Office of Judicial Records shall immediately collect \$90.25 representing the Superior, Commonwealth and Supreme Court of Pennsylvania's cost for filing an appeal plus \$257.94 representing the Court of Common Pleas of Philadelphia's cost for filing an appeal.

All changes to the JCS/ATJ/CJEA/OAG fee will be reflected in the Court of Common Pleas of Philadelphia Fee Schedule effective **November 27, 2017.** The new schedule will be published on the First Judicial District of Pennsylvania's website.
