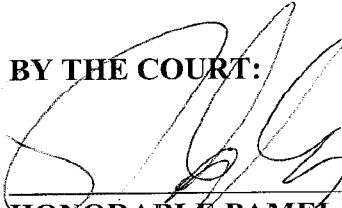

AND NOW, this 29th day of December, 2009 as provided in Joint General Court Regulation No. 2008-01 and this Court's Order dated July 17, 2008, a *Certification of Premises As Residential - Owner Occupied and Request For Conciliation Conference* having being filed with the Prothonotary, and Conciliation Conferences having been scheduled and not having been concluded in connection with the cases on the attached list, IT IS HEREBY ORDERED, ADJUDGED and DECREED that the Sheriff of Philadelphia postpone at the Court's direction those cases on the attached list which are currently scheduled for the January 5, 2010 Sheriff Sale to the March 2, 2010 Sheriff Sale or to a subsequent Sheriff Sale date as may be requested by the Plaintiff.

IT IS FURTHER ORDERED and DECREED that the Sheriff Sale of any properties at issue in cases which were subject to a Conciliation Conference which has been concluded shall be postponed at the Court's direction to the Sheriff Sale date identified in the Order issued after the Conciliation Conference or, if no date is identified in that Order, to the March 2, 2010 Sheriff Sale or to a subsequent Sheriff Sale date as may be requested by the Plaintiff. At the January 5, 2010 Sheriff Sale, Plaintiff's attorneys shall provide to the Sheriff, if requested, a copy of any order issued at the Conclusion of the Conciliation Conference to assure compliance with this provision.
