IT IS FURTHER ORDERED and DECREED that the Sheriff Sale of any properties at issue in cases which were subject to a Conciliation Conference which has been concluded shall be postponed at the Court's direction to the Sheriff Sale date identified in the Order issued after the Conciliation Conference or, if no date is identified in that Order, to the April 7, 2009 Sheriff Sale or to a subsequent Sheriff Sale date as may be requested by the Plaintiff. At the February 3, 2009 Sheriff Sale, Plaintiff's attorneys shall provide to the Sheriff, if requested, a copy of any order issued at the Conclusion of the Conciliation Conference to assure compliance with this provision.
