

CASE MANAGEMENT CONFERENCE

- Held 90 days after lawsuit commenced.
- Case management order issued "on the papers;" no appearance by counsel at conference.

ONE YEAR STATUS

- Short form memorandum due 15 days prior to conference.
- Discuss status of discovery; expert reports; dispositive motions; stipulations of dismissal of parties.
- Plaintiff required to make reasonable demand.
- Discuss early resolution via JPT settlement conference or private mediation.
- Note that counsel may no longer make private agreements to extend CMO deadlines.

CERTIFICATION OF EXPERT REPORTS

- Certification that ALL expert reports for ALL parties have been exchanged will be filed by plaintiff's counsel no later than 10 days after defendant's expert reports are due.
- If Certification is *not* timely filed, the case will *not* be listed for a Pre-trial Conference. A Notice will be issued to all parties that a Rule to Show Cause (why expert reports have not been exchanged) hearing will be scheduled in 20 days. Rule Hearings take place in Room 246, City Hall.
- Rule Hearing sanctions may be imposed upon counsel for failure to reasonably comply with Case Management Orders.

PRE-TRIAL CONFERENCE

- Notice of Pre-trial Conference sent 60 days in advance.
- Comprehensive Pre-trial Memorandum due 15 days before conference.
- Counsel must meet and confer prior to conference to get 3 mutually available trial dates within 6 months to propose to the Court.
- Counsel for defendant must have authority to make a reasonable offer or state that it is a "no pay" case to be listed for trial.
- If no offer is made, the case will be deemed ready for trial. Counsel should expect to go to trial within 90 days.
- Counsel for all parties must have authority to respond to Court's inquiries concerning JPT settlement conference or private mediation.
- Trial date will be assigned.

90 DAY STATUS

• Evaluation with Dan Sherry, Esq. or Peter Hoffman, Esq. for early settlement via JPT Settlement Conference or private mediation.

JPT SETTLEMENT CONFERENCE

- Opportunity to engage in a 3-hour settlement conference with a highly experienced medical malpractice attorney at no cost.*
- Pre-requisites for approval for a JPT Settlement Conference:
 - o All parties requesting the JPT Settlement Conference have authority to negotiate in earnest;
 - o Necessary consents/tenders are in place;
 - o Plaintiff has made a reasonable demand; and
 - o Defense has made a reasonable offer or confidential communication of settlement authority.
- Procedure for scheduling a JPT Settlement Conference:
 - o Parties can request that the Conference be scheduled in 30, 60, or 90 days depending on proximity to trial date.
 - Notice of Scheduling Conference will be issued this is a short discussion to select dates for the JPT conference only. It is not the settlement conference.
 - o Upon receipt of Notice of Scheduling Conference, counsel should meet and confer to select 3 mutually available dates for JPT Conference.
 - o Order will be issued for a JPT Settlement Conference. JPT is assigned by the Court; counsel is not able to choose.

TRIAL READINESS CONFERENCE

- Held on Friday or Monday prior to jury selection.
- Trial counsel must attend.
- Discussion of potential settlement, agreement on motions in limine, and trial schedule.

^{*}The parties can request a JPT Settlement Conference at any time up to and including the 90 Day Status Conference.
