

## New Civil Electronic Filing Feature Re: Notice Information

### Overview:

Effective October 4, 2021, Civil Electronic Filing System (EFS) users will have the ability to view information about what notices have been sent by the Court. Information included is when notices were sent, to whom they were sent, and how they were sent.


Notices from the Court include those of court orders and other documents required by PA.R.C.P. 236, scheduled court events, and the acceptance of electronic filings.

The information regarding notices sent can be obtained in the My Civil and Orphans' Court Cases section of the EFS.


### Illustrated Guide:

To retrieve notice information select the My Civil and Orphans' Court Cases on the home screen after logging in to the EFS.

*Note: Orphans' Court notice information will not be available.*



Once on the My Cases screen, the user may enter any combination of information in the fields at the top of the screen or scroll through the list of cases to locate the case of interest.  
*Note: A user must have an active appearance on a case in order for that case to appear in the My Cases section in the EFS.*



Under each case's information, the user will be presented with three new hyperlinks to access notice information. If there is information available, the hyperlinks will be active indicating the number of notices.

Clicking the link labeled "Pursuant to PARCP 236" will take the user to a new screen with information including the date something was docketed, what was docketed, and how many recipients were noticed. Clicking the arrows next to the number of recipients will expand the information to show who was sent notice, when it was sent, and how it was sent.

Clicking the link labeled “E-Filings” will take the user to a new screen with information including what was electronically filed, the date it was filed, the subject e-filing number, who filed it, and how many recipients were noticed. Clicking the arrows here will display the additional information of who was sent notice, when it was sent, how it was sent, and which type of notice was sent. Each accepted e-filing will generate a notice to the filer (“Acceptance Email”) and other case participants who are registered EFS users (“Notification Email”) to indicate the filing has been accepted and docketed.
