5. The Nomination Papers therefore fail to conform to the requirements of the Election Code, and must be set aside and the Candidate’s name not be placed on, or stricken from, the ballot.
6. Petitioner respectfully reserves the right to add such additional objections as are appropriate at the time of hearing.

WHEREFORE, Petitioner prays this Honorable Court to issue a Rule upon the Candidate and upon the Philadelphia County Board of Elections to show cause why the Nomination Papers of the above referenced Candidate should not be set aside and the Candidate’s name shall not appear on the 2019 General Election ballot.
