Awbury View Apartments is located in northern Philadelphia. The 3.5 acre property contains 38 one-bedroom units, 60 two bedroom units, 22 three bedroom units, and 4 four bedroom units. Each unit features a range/oven, a refrigerator, and garbage disposal. There is carpet in the living room, dining room, and bedrooms. A community room with a full kitchen and powder room is available for all residents. On-site retail services are also available to the residents, including a deli/market, dry cleaners, and a beauty supply store.

Section 8 Housing

Pennsylvania Housing Choice Voucher program, also known as Section 8, provides housing choice vouchers to eligible families and individuals living in the state of Pennsylvania and unable to afford safe and sanitary housing. The program is funded by the U.S Department of Housing and Urban Development (HUD). The local Public Housing Authority (PHA) administers the program locally to ensure that each applicant goes through a comprehensive eligibility test and meets Section 8 requirements before receiving rental subsidy.

The Section 8 recipients can find a housing unit of their choice in the public housing market. However, the housing unit has to meet HUD's requirements. Your local PHA will inspect the housing unit and determine whether or not it meets Section 8 requirements.

Once a Section 8 tenant has selected a housing unit, PHA will sign a contract with the landlord to provide rental subsidy directly to him/her instead of handing it over to the tenant. The tenant will also sign a contract of lease with the landlord to pay the rental amount left after subsidy payment. Eligible families often need to pay up to 30% of their rent and utilities while the rest will be covered by the Section 8 subsidy.

The rental subsidy is also available through project-based rental assistance. Successful applicants will be able to select a subsidized housing unit in a specific building. The PHA will sign a contract with the building owner to include it in project-based Section 8 units. You can find Section 8 subsidized houses using this link

(http://www.hud.gov/apps/section8/step2.cfm?state=PA,%20Pennsylvania). If funds last, Section 8 program will also accept applications for a Homeownership Program for Section 8 households. A household should have low-income to qualify for the Pennsylvania Section 8 Housing Choice Voucher program. Your local PHA will verify your income and if its below 50% of the are median



income, you will be able to to apply. Initially, you will be put on a waiting list after meeting the basic requirements. Once you've reached the top of the list, you will receive a notification for interview and detailed eligibility test. After you qualify both, you will be given a housing choice voucher that can be used for renting a housing unit in the public market or Section 8 subsidized buildings.

Who can Qualify for Section 8?

In order to receive Pennsylvania Section 8 Housing Choice Voucher assistance, you will need to meet the following requirements.

Income requirements

Your household income should be at or below 50% of the area median income. However, you can qualify for Housing Choice Voucher program if your income is above 50% but below 80% and Tenant Requirements

- Preference is given to families who earn less than 30 percent of the median area income.
- o If approved for a house choice voucher, you will then be placed on a waiting list until suitable housing comes available.
- Your local public housing agency maintains the right to extend preferential treatment to those who are currently homeless, who have been involuntarily displaced, or who currently pay more than 50 percent of their entire income for housing.
- Once enrolled in the house choice voucher program, tenants are required to adhere to the terms of the one-year lease, pay rent on time and take good care of the dwelling.

These are the basic requirements to qualify for a house choice voucher. If approved, it's up to you to locate suitable housing from someone who accepts HUD payments. Typically, as a HUD-approved applicant, you'll pay between 30 and 40 percent of your monthly rent, and HUD will cover the

remainder.

Citizenship

You should be a US citizen or a qualified alien with all the necessary legal documentation to be considered for Section 8 program.

Other requirements

In order to be eligible for Section 8 program, you must not have

- been evicted from a Section 8 or another public housing
- o a drug related criminal record

How to Apply

To apply for Pennsylvania Section 8 Housing Choice Voucher program, you will need to follow these tips.

- Locate your nearest PHA office using this <u>link</u> (<u>http://www.hud.gov/offices/pih/pha/contacts/states/pa.cfm</u>).
- Check with PHA if the waiting list is open. If waiting list is open, you can obtain an application from PHA office.
- o Fill the application, completing all details, and attach all the necessary documents with it before submitting it to PHA.
- o Once your name has come up on the list, PHA will send a notification.

Housing for Homeless

- Homeless Centralized Intake Services OSH staff assesses eligibility and service needs of consumers presenting for placement into emergency housing. Consumers are placed in appropriate emergency housing, boarding homes, or alternative housing. Mental health assessments and referrals to drug/alcohol treatment, health services, children and youth services, legal services and veteran's services, etc. are provided as needed.
